Understanding the Context of Domestic Violence: Identifying and Addressing Coercive Control

#### Understanding the context of domestic violence

Judicial officers hearing cases involving domestic violence encounter tremendous challenges in making fair and effective decisions, whether they preside over criminal or civil dockets. Because domestic violence typically is patterned and part of a dynamic course of conduct over time, judicial officers cannot simply assess a single incident or snapshot in time. Instead, effective decision-making that holds abusers accountable and provides for the safety of victims and children demands a careful analysis of what we refer to as the **context** of the abuse: the abuser's intent or purpose for the abusive acts, the meaning of those acts to the victim, and the effect of the abuse on the victim (and children). Only by assessing all three of these components can a judicial officer fully understand the context of domestic violence in a case and tailor a response that accounts for it. As an example, if an abuser threatens a victim that if she leaves him "you will never see the kids again," a contextual analysis could look like this...

Judges in family law cases face the task of making life-altering decisions on a daily basis. These decisions have far-reaching implications when there has been, or continues to be, controlling or abusive behavior in a relationship. Family courts and the law have traditionally placed an emphasis on maintaining the parent-child relationship intact and unencumbered. However, as courts and legislatures recognize the lifelong effects of domestic violence; there has been an emphasis on balancing a domestic violence perpetrator's right to parent with the physical and emotional safety of a child or at-risk parent. Supervised visitation is one remedy that courts have relied upon to reach this parenting/safety balance...
